

МоиЗэго Terms of Service (Offer Agreement)

Revision: 17 February 2026

This document is a public offer made by Sole Proprietor **Pavel Aleksandrovich Kondakov** (hereinafter, the “Company”). By clicking “Accept” / “Continue” or by accessing the МоиЗэго bot/web service, the user confirms that they have read, understood, and fully accept these terms.

1. Definitions

- **Service / МоиЗэго** – the bot, web application, and any other software components that provide access to tests, recommendations, and materials related to transactional analysis.
- **User** – any legally capable individual who registers/logs into the Service and uses it.
- **Materials** – tests, texts, visuals, chat interactions, AI-generated responses, and any other content available within the Service.

2. Subject of the Agreement

2.1. The Company grants the User access to the Service for taking tests and receiving information on ego-state theories. 2.2. The User agrees to comply with these terms and to use the Service only for lawful personal or professional purposes.

3. Access and Accounts

3.1. Access may be provided via Telegram bot, web version, or other interfaces. 3.2. The User is responsible for the accuracy of their contact data and for maintaining the confidentiality of their credentials. 3.3. The Company may restrict access in cases of rule violations or suspicious activity.

4. Data Usage

4.1. **The Service does not collect personally identifiable data**, except for technical information required for proper operation (messenger ID, cookies, event logs). 4.2. Any additional data provided voluntarily by the User is used solely to display results and is not shared

with third parties without separate consent. 4.3. Data processing follows the Privacy Policy and applicable Russian law.

5. Nature of Materials and Liability

5.1. **All Service content is informational and entertainment-oriented** and does not constitute medical, psychotherapeutic, or educational services. 5.2. **The Service materials are not official training courses or certified methodologies.** 5.3. **The Company bears no responsibility for AI-generated answers**, including possible inaccuracies or interpretations. The User independently evaluates how to apply the information. 5.4. Any actions taken based on the Service materials are performed by the User at their own risk.

6. Acceptable Use

6.1. Users must not interfere with the Service, distribute malicious software, engage in spam, or use the Service for unauthorized mass messaging or automated data extraction. 6.2. The Company may block access for violations or upon request from competent authorities.

7. Intellectual Property

7.1. All rights to the Service and its content belong to the Company unless explicitly stated otherwise. 7.2. The User receives a limited, non-exclusive, revocable license within the scope of the Service functionality. 7.3. Copying or using materials beyond the permitted scope requires written consent from the Company.

8. Limitation of Liability

8.1. The Service is provided “as is.” The Company does not guarantee error-free or uninterrupted operation, nor alignment with the User’s expectations. 8.2. The Company and its partners are not liable for direct or indirect damages arising from use or misuse of the Service. 8.3. The User indemnifies the Company against claims from third parties related to the User’s actions within the Service.

9. Payments (if applicable)

9.1. Fees, billing details, and refund policies are specified directly within the Service interface. 9.2. Paid services are deemed delivered once access to the relevant functionality is granted.

10. Changes

10.1. The Company may amend the Agreement unilaterally. The updated version becomes effective upon publication or on the stated date. 10.2. Continued use of the Service after changes signifies consent. If the User disagrees, they must stop using the Service and may request data deletion.
